#### Scholarship

Karen brought forward some suggested changes to the Scholarship Guidelines for the board to vote on.

Section 2. Basis of RMDS Scholarship Awards Add d. Financial need is based on whether or not the applicant could pursue this opportunity to further their knowledge of and experience in dressage without receipt of the scholarship funds. Ability to complete the applicant's training plan in full with a scholarship will be considered.

Section 5. Obligations of Scholarship Recipients Add to a. Online training programs are considered an eligible activity.

Section 6. Scholarship Application Period and Award Decisions Add a.iii. Generally, individual scholarships will not exceed \$500 except for the Barbara McElnea scholarship, which will not exceed \$1000. The RMDS Executive Board will make the final decision, which may differ from the Scholarship Committee's recommendation.
