**Central Office Report:** USDF Membership due by Nov 11 in order to get discount for Kyra Symposium. 1030 RMDS members for 2008, of those 14 Centaurs only. There

are 166 horses on file since 9/30/07. Membership dues will be \$60 as of Jan 1, 2009, currently \$55. Heather Petersen and Rusty Cook are new USEF TD's for the area. All Chapter Director's will be under the RMDS D&O Insurance umbrella as of Jan 2009. List must be submitted to Central Office by Jan 8, 2009 Executive Board meeting. Country Supply purchases made online translate into a small percentage returned to RMDS. It was suggested that an email about this program go out from RMDS to all members.

#### **Committee Chair reports**

#### AA report: None

**Jr/Yr report**: Susan Rudman reported that the Jr/Yr fundraising efforts were successful last yr, raising over \$3000. Still selling USDF Region 5 T Shirts and Horse inspiration bracelets. The Jr Camp had 6 participants this past year, hope for more next year. Region 5 Juniors won Team Gold at the NAYJC held at the CHP. Individual Gold was won by a 14 yr old, youngest ever. Julie Barringer-Richers discussed the return of the USDF Region 5 Team Championships. Autumn Hill is donating facility for this event possibly in July. This event would model other programs currently on the USDF Region 5 website.

**Awards**: Barb Goldman reported that after holding two special awards meetings this past year some changes have been implemented. Sweepstakes awards will be eliminated starting in 2009, Chapter volunteers will receive a plaque in addition to the small gift, and stall plates have been replaced with a keepsake plaque. Concerning trophies that were not "accepted" at the banquet it was decided that the owner/rider would be asked to cover the cost of engraving but if they are unwilling, RMDS will cover cost to maintain historical accuracy. An awards booklet was in the works to highlight the various awards available with description, donor info and a picture. Two new awards have been suggested for 2009: High Median Pony for Jr.Yr at any level and High Median American Breed. The issues with the American Breed Award were discussed, as being too difficult to track as it is too broad.

#### Championships -

Debbie Wilke presented some statistics about RMDS 2008 Championships Show. 184 horses entered in RMDS Ch. Classes, 30 in the Sport Horse competition. 413 rides were Training level thru 4<sup>th</sup> level, 44 were FEI. Freestyles were down from previous years with only 11. 18 horses <u>trailered</u>in to show, the rest were stabled on grounds. Debbie also discussed the 30-day prior to show policy for prize lists. If prize list is changed after that time period all participants must be notified.

# Winter Wake Up show and Championship Show follow up:

Heather Petersen reported that the RMDS Winter Wake Up show 2008 lost \$4600. Some changes implemented for this coming year 2009. Date moved to April 4-5, not offering High Performance status that will save about \$1900 in expenses, increased class fee by \$5, and budgeted a loss with RMDS for 2009. This show crucial to those Jr/Yr's trying to qualify for National JR/YR Championships. RMDS Championship Show for 2009 will be more expensive due to CHP fee's going quite high. The stabling fees alone have increased by approximately \$9000.00, the arena fees have increased from \$3900 to 6000.

Heather prepared a sample prize list for 2009 RMDS Championships and discussed where the cost increases would most likely occur.

# **Communications:**

Nicole Bizarro reported that she was resigning as Communications Chair at the end of 2008. She will continue to produce the Omnibus and hopes to save printing costs by using a direct digital printer for 2009. Ad rates for both the Centaur and the Omnibus saw a modest increase of approximately \$5.

**Website**: Michael Petersen's report stated that the marketplace ads continue to grow. He is working on adding more automation to allow Central Office more real-time information ability.

# **Education:**

Heather Petersen reported that all demo riders for the Kyra Kirklund Symposium have been selected. RMDS Judges' Continuing Ed will be at Freedom Farms in 2009, Janet Foy will be the instructor, and a grant from The Dressage Foundation has been applied for. This will be a USDF Continuing Ed program.

TD/Show Management Education will be Feb 7, 2009 in Castle Rock. Room donated by Comfort Suites and Deeda will teach TD portion and Camille Griffin, Laura Speer and Heather Petersen will do the show management portion. Heather reported that previous Continuing Ed programs each made a profit. Future events already planned are L program D2 at Sommerset Farm in Boulder and Final at CHP in Aug. Reminder that RMDS Executive Board Officers receive a 50% discount at RMDS sponsored educational events.

# Scholarship:

Simone Windeler reported that there are 4 Scholarships to be awarded. Each recipient will be receiving \$250 for 2009. Opening Date of Dec 1<sup>st</sup> until Dec 31<sup>st</sup>. RMDS is encouraged to grow and support funding thru sponsorship and advertising.
