Mary Jo Hoepner motioned that CSDA be added to the D&O Insurance. Renee Martig seconded, and all were in favor.

# Office:

• Always here for you.....

All Chapter Presidents are encouraged to reach out to their past members who have not yet renewed. We are behind this year in membership renewals compared to previous years. Show Season starts in April!

There was discussion about the Colorado Horse Park, and all members are encouraged to continue to speak of the CHP in a positive way. We would like to continue to build a healthy relationship with the new owners of the CHP, so that Dressage can continue to be a big part of the events held there.

Omnibus loss is significantly less than previous years; it was suggested that next year we include the "Pyramid of Training". If you have suggestions of where this should be included in the Omnibus, please let us know!

Currently, Platte River and Wasatch Mountains only have six (6) members each, making them incomplete chapters. Currently, the by-laws state that membership requirements for each chapter must be met by April 1<sup>st</sup> of the membership year. Mary Jo Hoepner motioned that the chapter's compliance be re-evaluated at the July meeting. Heather Petersen seconded, and all were in favor. Meanwhile, the chapters will not receive funds until they reach the minimum ten (10) member requirement. There was discussion that a possible by-law revision should be made.

## **Permanent Committee Reports:**

1. Adult Amateur Didi DeKrey

To continue with outreach, I have spoken with several of our chapter presidents, barn owners, fellow adult riders, clinicians and trainers. There are a few common threads:

- Those that show appreciate having a non-professional division available
- Many adults (not necessarily official Adult Amateurs) are still hesitant to enter the recognized show venues
  - Cost is a significant factor
  - o "Type" of horse they have
  - Location of shows or rather, the lack of locations
- Clinics be they with a clinician or a Ride A Test format are extremely popular
  - Again, cost and location are limiting factors
    - Cost (\$100 +) prohibits participating in more than one, thus, these riders are not able to progress frustrating for them and the clinician!

The Chapters I have spoken with, have many activities planned for this year. All are open to other chapter members to participate in their various activities. Some of the individual adult riders are still not aware of the difference in being an adult and an amateur vs an Adult Amateur.

Based on these findings, and the review of the more official survey from 2009, I suggest the following concepts:

- RMDS sponsored clinic; use of RMDS trainer(s)
  - Up to 3 locations about the RMDS region
  - First come, first served AAs
    - Group sessions are a possibility
    - Introductory through 2nd level
  - Budget estimate: \$2,000

■ Exhibitors cost: \$50 = \$75

Auditors cost: \$25 - \$35

- RMDS sponsored Ride A Test; use of RMDS Judge(s)
  - Up to 3 locations about the RMDS region
  - First come, first served AAs
    - Introductory through 2nd level
  - Budget estimate: \$2,000

Exhibitors cost: \$50 = \$75
 Auditors cost: \$25 - \$35

- RMDS sponsored Horse/Rider clinic
  - o i.e. how to work with your knowledge, your horse no matter what the expertise or breed
  - concept of lectures, lunging, mounted session(s)
  - Budget estimate \$2,000
    - Daily rate of \$200 per horse/rider combination
    - Auditors (space permitting) \$45/day
- Donate \$\$ to Chapters to supplement existing venues
  - AAs have first go at the supplement
  - o Budget \$1,200
    - Split between all the Chapters
    - No monetary reimbursement

A more detailed cost and itemization would be submitted to the Executive Board for the concept(s) approved this March meeting. Time frames would be dependent on facility and clinician schedules. Happy Trails!

The afternoons were spent at Tomora with wonderful demonstration horses. Thanks to Heather Petersen and Nicole and Natalie for providing the horses and venue.
- Jan 31 L Program CE Freestyles This fantastic program developed by Terri Ciotto-Gallo wa
  presented by Debbie Riehl-Rodriguez. Highly informative and detailed, this program designed for
  judges, was also very valuable to exhibitors. The information provided can not only help judges, but
  also help develop better freestyles for judges to judge. Profit \$825, would like to consider returning
  the \$200 grant check from the Dressage Foundation, so that money can go to another program that
  needs it.
- Feb 28 New test clinic This clinic was wildly successful, and despite the need due to weather, for a last minute change in venue and format, garnered rave reviews from attendees. 4. Foothills Kris Cooper

We began the year soliciting interviews from our membership. The input/ideas of those who volunteered to be included are summarized below:

- 1. It is a lot more difficult for a new person to become involved with dressage than it used to be.
  - a. The cost of showing and preparing for shows is beyond the means of the average person.
  - b. Onlookers associate dressage with stress and formality.
  - c. "Dressage used to be fun."
- 2. We need pathways to interest more people in dressage and to keep them involved.
- 3. Dressage doesn't exclusively mean showing to everyone. Dressage means training.
- We need events that are inclusive and fun.
- 5. We need to encourage more people to join our chapter and hence RMDS.

As a result of these discussions four new events are planned for 2015:

- A western dressage clinic with Frances Carbonnel will be held on Sunday, April 12. This
  clinic is sponsored by our chapter and sanctioned by the Western Dressage Association of
  Colorado.
  - a. The purpose of this clinic is to expose people to dressage who might otherwise be turned off by the perceived artificial and formal nature of dressage.
  - b. Correct dressage training is beneficial to all horses.
  - c. Western dressage serves as an alternative to training methods that might otherwise be detrimental to the horse's physical and psychological wellbeing.
  - d. We hope to convert new people to traditional dressage (and RMDS) through western dressage.
  - e. Western dressage also serves as a new show venue for current dressage trainers and riders.
  - f. The Foothills Chapter's geographical area will be home to at least four shows this year that feature western dressage classes.
- 2. A Show Preparation workshop will be held on April 20.
  - a. We hope to introduce new people to showing and to make showing sound fun.
  - b. We will also encourage new people to become volunteers at our shows.
  - c. A Ride-A-Test Clinic with KC Parkins-Kyle will be held May 3 at Table Mountain Ranch.
- 3. A schooling show on June 7 will culminate our above efforts. Stephanie Soule will judge. We hope to provide mentors for anyone new to showing who does not already have a trainer/coach. We will also provide low-key opportunities for those new to volunteering..
