VENDOR AGREEMENT – USDF Region 5 / RMDS Championships 2016

This agreement is by and between 2 White Feet, Inc. (Management), as Management for the USDF Region 5 and RMDS Championships and Open Show and Rocky Mountain Sport Horse Championships at the Stanley Park Fairgrounds in Estes Park, CO and the Vendor as indicated on the vendor reservation form. These two pages together constitute the entire agreement between the Management and the Vendor. Disputes under this agreement will be resolved pursuant to the laws of the State of Colorado.

It is agreed that the Management will provide space in vendor row, for the vendor's exclusive use throughout the days of the show specified for the display and sale of the vendor's wares and/or services. In consideration, the vendor will pay Management the appropriate cost pursuant to the space and days chosen on the reservation form. Management will provide light and electricity to Vendor, but the Vendor will be charged for electricity at a daily rate as set by the Stanley Park Fairgrounds (the facility). Payment in full is to be made no less than fourteen (14) days prior to the first day of the event via **check made payable to RMDS**. A non-refundable deposit of \$50 is required to hold space in the vendor area.

INSURANCE POLICY REQUIREMENTS (**FOOD VENDORS ONLY**): Insurance must commence one day prior to the start of the show and continue through the last day of the show.

- ➤ All reservations for vendor space must be accompanied by a Certificate of Liability Insurance if selling freshly prepared food (does not include package goods) or using machinery naming the Stanley Park Fairgrounds and the Town of Estes Park.
- ➤ Vendors selling food (does not include packaged goods) products must supply a Certificate of Insurance showing minimum liability coverage of \$1,000,000 (one million dollars) naming the Stanley Park Fairgrounds and the Town of Estes Park as an additional insured.
- ➤ All food vendors must also possess a current catering license in Larimer County, Colorado or a county they have an agreement with.

Hold Harmless Agreement: Vendor agrees to release, indemnify and hold harmless, regardless of negligent acts or omissions, 2 White Feet, Inc., the horse show management, The Stanley Park Fairgrounds, the Town of Estes Park, the State of Colorado, the Rocky Mountain Dressage Society, the show committee and all horse show personnel. No claims for injury to any person or damage or loss of property on account of fire, theft, or other cause shall be made against Management, the owner or operator of the facility, the State of Colorado, and/or it's employees and all horse show personnel on account of the Agreement. Vendor agrees to indemnify and hold harmless of and from all claims for personal injury, death or property damage and any other losses, damages or expenses, including attorney's fees that arise out of, in connection with, or by any reason from the use of space provided herein by lessee.
